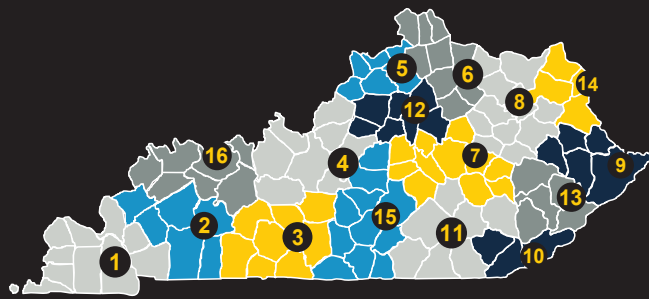

## THE ANGEL INITIATIVE MISSION IS A FOCUSED RESPONSE TO ASSIST INDIVIDUALS WITHIN THE COMMUNITY STRUGGLING WITH SUBSTANCE USE DISORDER

### DISQUALIFIERS FOR THE PROGRAM

- Outstanding arrest warrant or non-extraditable arrest warrant in another jurisdiction
- The participant is a registered sex offender in any state
- Reasonable belief others could be harmed by participant
- An Unaccompanied Minor

The Angel Initiative does not apply to those persons seeking to complete court-ordered treatment, to fulfill sentencing obligation, or those persons encountered during regular law-enforcement duties.

### WHAT TO EXPECT WHEN YOU ARRIVE AT POST

- Come to ANY Kentucky State Police Post and ask to participate in the Angel Initiative.
- You will be asked to provide a photo ID or other means of identification.
- It is helpful to have a copy of your insurance information but this will not disqualify you from participating. Many facilities accept non-insured individuals.
- You will be asked to sign a Participant Agreement Form granting permission to conduct a records check and submit to being searched.
- If you have any drugs and/or drug paraphernalia on your person, you will not be charged, jailed, or investigated. The drugs and/or paraphernalia will be confiscated and destroyed as soon as possible.
- You will be asked to provide information during the intake screening to determine the best treatment options for you. The Angel Coordinator will work quickly to locate a treatment facility to best meet your needs.

If at any time during the intake process you decide to discontinue services, you may do so without any consequences. This is a voluntary program.

### WHAT ARE THE OBJECTIVES OF THE ANGEL INITIATIVE?

The Kentucky State Police started the Angel Initiative in 2016 with one main goal:  
**To Save Lives.**

Kentucky State Police seeks to forge collaborative partnerships within the community to address substance use disorder, to reduce and prevent the threat of overdose and overdose death.

Available statewide, persons experiencing substance use disorder can come to ANY of the 16 Kentucky State Police Posts for assistance locating treatment.

Eligible persons voluntarily seeking assistance will be treated professionally and compassionately during the entire process in obtaining treatment without fear of prosecution.

Kentucky State Police will continue to pursue and prosecute those trafficking illicit and prescription drugs, but if you find yourself needing assistance in escaping the grip of substance use disorder, we are here to help.
